DEFIANT RED ROOSTER clean trip away from the gates, rallied strongly down the outside. GW SHEZASPECIALROSE sharp start from the inside, rallied just off the rail, caught late, second best. GREYICE broke straight in from the start, bumping PAINTED STORM CAT into THATS LAME SAUCE MAN into DREAMGIRL ON FIRE costing them any chance to contend, rallied on to finish 3rd before being disqualified and placed last. ROYAL DIAMOND CARTEL bobbled at the start, clean trip after the start, outfinished. CAPTIVATING CARA clean start, failed menace. PAINTED STORM CAT bumped hard at the break, no chance to contend for the win, rallied on late. DREAMGIRL ON FIRE troubled by rivals to outside, failed to recover to contend. THATS LAME SAUCE MAN troubled at the start by rival to the outside, no factor. THE STEWARDS' CALLED FOR AN INQUIRY BECAUSE OF TROUBLE AT THE START CAUSED BY #6 GREYICE. HE WAS DISQUALIFIED FOR INTERFERING WITH MULTIPLE RIVALS TO HIS INSIDE AND PLACED LAST. GW SHEZASPECIALROSE WAS DISQUALIFIED FROM SECOND TO UNPLACED FOR A POST RACE MEDICATION VIOLATION.
