FOR QUARTER HORSES, THREE YEARS OLD, WHICH WERE ORIGINALLY NOMINATED TO THE MINNESOTA STALLION BREEDERS' FUTURITY AND/OR OWNERS THAT ARE RESIDENTS OF ELIGIBLE STATES \$50 to nominate by Saturday, April 1. Sustaining payment of \$150 due by Wednesday, May 10. \$300 due at time of entry for trials. LATE FEE SCHEDULE: \$400 to nominate by Wednesday, May 10 or \$1,000 at time of entry to the trials (includes all fees), for horses not originally nominated by April 1. \$20,000 Added (Includes \$11,000 from the Mystic Lake Purse Enhancement Fund.) Purse to be distributed to the 10 fastest qualifiers: 50% to the winning owner, 20% to second, 10% to third, 7% to fourth, 5% to fifth, 3% to sixth, 2% to seventh, and 1% to eighth, ninth and tenth. Eligibility for Gopher State Derby: Owners must be a resident of the following states or provinces: IA, ID, IL, IN, KY, MI, MN, MO, MT, NE, ND, OH, SD, UT, WI, WY, and Canadian Provinces. PAYMENTS MUST BE POSTMARKED BY THE DATE LISTED OR LATE FEES WILL APPLY. Management reserves the right to cancel, change or postpone dates of trials and/or final. A trophy will be presented to the winning owner. Trials to be run Saturday, May 27, 2017.
