FOR ELIGIBLE QUARTER HORSES, TWO YEARS OLD Sustaining payment of \$125 due by Saturday, April 1, \$150 additional to enter the trials. LATE FEE SCHEDULE: \$1,000 due by Saturday, April 1 or \$2,500 at time of entry to trials for eligible horses which did not make original nomination payment. \$20,000 Added (Includes \$11,000 from the Mystic Lake Purse Enhancement Fund) (Plus \$5,000 from the Minnesota Breeders' Fund for Minnesota Sired and Foaled horses) plus nomination, sustaining and entry fees. Purse to be distributed to the 10 fastest qualifiers: 45% to the owner of the winner, 20% to second, 10% to third, 6% to fourth, 5% to fifth, 4% to sixth, 3% each to seventh and eighth and 2% each to ninth and tenth place. Weight: 122 lbs. ORIGINAL NOMINATIONS CLOSED DECEMBER 1, 2015. SUSTAINING PAYMENTS DUE SATURDAY, APRIL 1, 2017. PAYMENTS MUST BE POSTMARKED BY THE DATE DUE OR LATE FEES WILL APPLY. Management reserves the right to run 11 horses in the final, with no trials, if 11 horses or fewer enter into the trials, paying purse monies only to the top 10 finishers. Management reserves the right to cancel, change or postpone the trials and/or final. A trophy will be presented to the winning owner. Trials to be run Saturday, June 17, 2017.
